4. **Applicants in the grade of E4 to E6 and who are qualified in the MOS 25S or who can become qualified within one year from date of selection may request assignment to this position. Unqualified applicants should note that training seats are subject to availability, and overall WYARNG DMOSQ allocations are subject to organizational need.**
5. Those Soldiers can apply by submitting a SWVA Assignment DA 4187, no other means of applying is authorized. Applicants must complete all the requirements in Section IV – “Remarks” of the DA 4187. 6. Soldiers in a nonpromotable status according to AR 600-8-19 para 7-4a-v may not apply for this postion.
7. **Soldiers may face bonus termination and recoument if selected and not in the parameters of their bonus contract.**
8. The SWVA Assignment DA 4187 must be sent via SIBX Hub, using the **UNIT – SOLDIER NAME – SWVA NUMBER** naming convention, and **EPM – SWVA / RFF** subaction to the EPM by the suspense listed above.
9. **In accordance with PPOM 18-001, paragraph 5e-f, Soldiers who are placed into E-6 and E-7 positions, and fail to meet the 24 month NCOES requirements outlined in AR 600-8-19, Table 7-4, will invalidate the selection and be cause for removal from the position. Soldiers in E-5 positions s who fail to meet the 12 month NCOES requirement will also invalidate the selection and be cause for removal from the position. Deployment situations will be taken into consideration.**
